Introduction

We, the USAFPA, have the honor to represent the USA in the upcoming Martial Arts Championships which will take place in Timisoara, Romania October 24th -28th 2024.

USAFPA is the nation's premier organization that supports pankration/amateur MMA athletes by providing opportunities for these athletes to compete in the highest, most authentic, and traditional level of the sport. As a non-profit organization, USAFPA also serves as the governing body in the United States for the Pankration/ amateur MMA.

The USAFPA is a 501 (c)(3) non-profit organization funded wholly by fundraising efforts from individuals, community and corporate donations. Each Athlete is ultimately responsible for covering their own training, and competition cost. The team will work together to achieve their funding goals, but the majority of the funding will come from donations.

Team USA

The USAFPA is a nonprofit 501c3 Tax Exempt Organization comprised of a staff of volunteers. All funds raised go directly to benefit of our Team USA.

The USAFPA delegation will be comprised of 60 athletes, coaches, and sanctioned referees.

Teams are comprised of ;

- 207 divisions between 6 disciplines, 5 age groups, and 81 weight classes
- Cadets Boys and Girls ages 12-14
- Juniors Boys and Girls 15-17 years old
- Young Adults, Men and Women 18-20 years old
- Adults, Men and Women 21-38 years old
- Masters Men and Women 39+ years old

More than 44,000 gyms teach a form of Pankration in the United States and approximately 3 Million people participate in the sport.

USA has just been selected as Host Country for the 2026 World Games.
This will be the first time the games will be hosted by USA
